VII. MISCELLANEOUS BUSINESS TO BE DISCUSSED AND CONSIDERED FOR APPROVAL:

1. Discuss and take appropriate action to authorize the Judge to sign the 1-year [contract](#) between Hood County and the Hood Central Appraisal District. (TAC, CJ)
2. Discuss and take appropriate action to increase the change drawer for Tax Assessor/Collector Granbury office from \$1,000.00 to \$2,000.00. (TAC, COM. P1)
3. Discuss and take appropriate action to submit to TCEQ an amendment to the rules of Hood County, Texas for On-site Sewage Facilities (OSSF) dated February 25th, 2014. The [proposed amendment](#) is to establish provisions for homeowners to maintain the OSSF at their primary residence (after initial 2-year period). Hood County homeowners may choose to self-maintain aerobic systems upon completion of one of the TCEQ approved courses listed on the Hood County website. This change is in compliance with Texas Administrative Code Title 30, chapter 285.7 which states “Homeowners who maintain their own systems are exempt from contract requirements, as provided in subsection (d)(4) of this section”. 4. Convene into executive session pursuant to Sections 551.071 and 551.072 of the Texas Government Code, to discuss purchase negotiations for property located in Precinct 1. Reconvene into open session and take appropriate action, if necessary. (TAC, PUR, COM. P1)
5. Consider and take appropriate action to issue Brazos River Acres 10 vouchers for Hood County Citizens Collection Station with an expiration date of September 30, 2023. (EH, COM. P2)
